DO NOT DRAW PICTURES ON MATERIALS.

Materials/photos become the property of the Town of Genoa and are not returned.

Your photos will be used to determine acceptance in the show.

A contract will be mailed after review of your application. All vendors will be considered on a first come/first serve basis.

- A. Load-in, set-up, breakdown, sales, and/or delivery items, is the sole responsibility of vendor.
- B. Reporting of sales tax is the sole responsibility of vendor. A Nevada Sales Tax form will be provided with your space assignment.
- C. Booth fees for a 10x10 outdoor space start at \$150.

Contract fee is due and payable when submitting the contract.
